Charging 100% success fees and risk assessments – Costs ...
Upon success the solicitor is entitled to standard hourly rates plus a Success Fee calculated as a % uplift on these hourly rates, to a maximum of 100%. A Conditional Fee Agreement (“CFA”) between a solicitor and his/her client requires an ability to define “success” for the purpose of triggering the solicitor's fees.

What is a Success Fee? - Francis Wilks and Jones
First, for those remaining CFAs to which section 44 of LASPO does not apply and in mesothelioma claims, it is that if liability is admitted before the CFA was made, a success fee of 100% will never be allowed even if it is staged.

“Old style” CFAs: the last hurrah for success fees ...
The High Court has refused to allow a personal injury claimant a 100% success fee on the grounds that a trial had not started before the case was settled, even though a hearing had begun. Applying the uplift had resulted in costs of about £320,000.

High Court refuses 100% success fee because trial had not ...
In Herbert v HH Law Ltd [2018] EWHC 580 (QB) Mr Justice Soole refused a solicitor’s appeal against a decision reducing the success fee from 100% to 15%. This is a very important decision for claimant personal injury lawyers who, habitually, claim a 100% mark up on a risk assessment in a personal injury case.

Using the court approved “Ready Reckoner” to calculate success fees, for cases which proceed to trial if there is a 90% chance of success this justifies a success fee of only 11%.
