The number of full-time and part-time employees/officers that received compensation or performed services during the reporting quarter are to be entered in section 1, for each corresponding month.

Form RT-6 is a Florida Corporate Income Tax form. Payment vouchers are provided to accompany checks mailed to pay off tax liabilities, and are used by the revenue department to record the purpose of the check and the SSN/EIN of the taxpayer who sent it.
