Transition begins before an agreement is signed and should involve the human resources team to identify employment-related liabilities and concerns. Acquisition Team HR has a role in the early stages of any acquisition: to evaluate compensation practices, employment contracts, benefit plans, retirement exposure, labor agreements and the talent pool.
